Change in Minor Subject at UG IV Semester (pertaining to 2024 Admitted Batch) and UG VI Semester (pertaining to 2023 Admitted Batch)

Applications are invited for allocation of a limited number of seats in various departments from students currently studying at UG III and UG V Semester and willing to change their Minor Subject at UG IV and UG VI Semester respectively. The students willing to change their Minors must submit their responses on or before 15th November, 2025 by 5 p.m. positively.

The University, following the guidelines of NEP-2020, shall facilitate a change of Minor subject under the following conditions. These conditions must be read carefully before filling up the aforesaid forms.

- 1. Only one chance will be given to a student to change their Minor Subject during entire course of the FYUGP after completion of UG III and V Semester. This is in accordance with NEP-2020 Guidelines of earning a minimum of 12 credits for a course to be considered as a Minor.
- 2. For January-June, 2026 session, change of a Minor Subject can be done after completion of UG III and V Semester respectively depending on availability of the seats as shared /to be shared by the respective departments.

- 3. Change of Minor Subject can be done only within the same domain of major subject/discipline Arts or Science. Students from Geography can apply for Minor Subject from both Arts and Science streams.
- 4. The syllabus of the Minor Course should be consulted by the applicants before applying for Minor Subject change to make a rational decision.
- 5. The re-allotment of Minor subjects would be based on respective standardized CUET Scores/HS Marks whichever applies accordingly.
- 6. Tie-breaking Rule: In the event of a tie, the result of the preceding semester (s) will be considered.
- 7. Students who have already changed their Minor in UG IV Semester during January-June 2025 session will not be permitted to make another change in UG VI Semester during January-June 2026 session.
