Applications are invited for temporary appointment of one Junior Research Fellow (JRF) at the Department of Environmental Biology and Wildlife Sciences for a period of 36 months (3 years) or till date of project completion whichever is earlier, under a DST-SERB funded project titled "Estimation of greenhouse gas fluxes (methane, carbon dioxide and nitrous oxide) from Deepor Beel, a Ramsar wetland site of Assam, and identification of associated environmental factors" under Core Research Grant Scheme.

Essential qualifications: M.Sc. with minimum 60% marks in Environmental Science or allied subject. NET (LS) /GATE qualified candidates will be given preference.
