## NOTICE

### (Admission to HS 2<sup>nd</sup> yr, UG/BCA 3<sup>rd</sup> & 5<sup>th</sup> Semesters, PG 3<sup>rd</sup> Semester and MCA 3<sup>rd</sup> & 5<sup>th</sup> Semesters)

This is for general information to all concerned that admission to regular HS 2<sup>nd</sup> yr, UG/BCA 3<sup>rd</sup> and 5<sup>th</sup> semesters, PG 3<sup>rd</sup> semester, and MCA 3<sup>rd</sup> and 5<sup>th</sup> semesters will be conducted ONLINE through the Cotton University website (<https://www.cottonuniversity.ac.in>) from **13 September 2019**, *except for those seeking admission under the Fee Waiver Scheme of Govt. of Assam*. The payment of fees will be accepted through debit/credit cards and online banking. **The last date of submission of fees for students without fee waiver is 17 September 2019.**

The fee structure for each course is available in the University website and students are requested to read the documents carefully.

**Fee Waiver:** The renewal admissions of students eligible for free admission shall be conducted on a date to be announced after declaration of UG & PG 2<sup>nd</sup>/4<sup>th</sup> Semester results (expected soon). The rules governing waiver of fees shall be as per Govt. O.M. No.AHE639/2018/11 dated 29/05/2019. The notification may be accessed online through the url

The following important points may be noted:

- (i) Students taking admission in any self-financing course are not eligible under this scheme.
- (ii) Students need to submit an income certificate from the Local Revenue Circle Officer which states that the parental income is less than Rs. 2.00 lakhs from all sources.
- (iii) Only those students seeking readmission in 3<sup>rd</sup> and 2<sup>nd</sup> year who had been admitted under the fee waiver scheme during 2017-18 and 2018-19 academic sessions shall be eligible to avail the scheme for the current year **provided they have requisite attendance and no back paper.**
- (iv) The students under the fee waiver scheme will have to pay three of the components of the total fees, namely, (a) **Students' Welfare and Activity fee**, (b) **Students' Union fee**, and (c) **Magazine fee.**
