## NOTICE

As per resolution of the 21<sup>st</sup> meeting of the Executive Council (Res. no. EC/2022/22/01) held on 10<sup>th</sup> February, 2022 which discussed the violent conflict between the boarders of SNBC and MNDP hostels in the night of 05 January 2022 and as per the report submitted by the "High Powered Hostel Committee" on this matter, it is notified that -

- (a) Mr. Kailash Doley (Enrollment Number PHL1831027) be fined Rs 7000/- and be debarred from taking admission into PG or any other courses of Cotton University for his involvement in life threatening attack on the boarders of MNDP Hostel.
- (b) Mr. Parvez Ali, (Enrollment No. GPH1932037) and Mr. Gunin Pegu (Enrolment No. PHY1932064) boarders of SNBC Hostel are fined Rs 7000/- each for violent activity. The fined amount must be deposited within 31<sup>st</sup> March 2022.
- (c) Mr. Nayan Jyoti Kalita, (Enrollment No. BCA1933027) is fined Rs 6000/= for staying in MNDP Hostel without admission and pretending himself to be the leader of the boarders of the MNDP Hostel and behaving rudely with superintendent of SNBC Hostel. The fined amount must be deposited within 31<sup>st</sup> March 2022.
- (d) All Hostel Boarders of both the Boys' Hostels involved in the incident between SNBC and MNDP are to be fined an amount of Rs. 2,500/- (Rupees Two Thousand Five Hundred) only as punitive action against misdemeanor and structural damages caused to University Hostels. Boarders with physical disabilities are excluded from the fine. The fined amount must be deposited within 31<sup>st</sup> March 2022.
- (e) Henceforth, any University student found guilty of being involved in such heinous acts by any Committee, Police or any other authority shall be deemed to have forfeited their seat with immediate effect. Such student shall be barred from admission in any course of the University.
- (f) Henceforth, in case of occurrence of any such incident, the concerned Hostels shall be sealed with immediate effect and boarders will be re-allocated till such time deemed appropriate by the University authority.
- (g) Superintendents of both the Boys' Hostels shall be relieved of their term with effect from 31<sup>st</sup> March 2022. The Director Students' Welfare shall be in-charge of the Hostels till the appointment of new Superintends.
