NOTICE

Cotton University announces its second “In House Research Project (IHRP)” for interested faculty members across all the departments of the University for the academic year by the faculty members as PI. The research works may involve Co-PIs also from other departments in order to encourage Interdisciplinary research work. The involvement of Local institutes/Universities will be encouraged. The Faculty members will be allowed to involve their Research students, PG students for Sample Survey, Data Collection & Analysis etc as per their convenience. The project grant will be maximum of Rs. 1(one) Lakh for Science Stream and Rs. 50(fifty) thousand for Arts & humanity stream.

Following points are the conditions for being deemed fit to apply for the In House Research projects (**IHRP**)

1. Those who have no other Research Project/Projects from any other agencies.
2. The faculty members should be permanent employees of the University.
3. No creation of physical infrastructure should be proposed.
4. No purchasing of Laptop/computer etc.

· The expenditure involved may be minor chemicals, books, minimum travel cost (cheapest), contingencies, Hiring or Cost of analysis/data collection at any Institute/laboratories.

· The proposals submitted by the interested faculty members will be screened by a **Selection Committee**, comprising of external experts and with the approval of the Hon'ble VC, the University would declare a list of 30 selected research proposals for the year.
