- iii. The empanelment of the Contractors will be for a period of 1 (One) year from the date of issue of the notice. However the University reserves the right to cancel the empanelment of any or all the Contractors and invite fresh proposals for empanelment at any time.

- iv. The University reserves the right to extend the period of empanelment of Contractors for further period depending on the requirement and the performance of the Contractors. The decision of the University in this regard would be final.
