- 1.3 The Earnest Money Deposit (EMD) shall be submitted in the form of **Demand Draft/ TDR** in favour of "**The Registrar, Cotton University**" payable at **Guwahati**. The EMD and the cost of tender document shall be submitted in the envelope containing the Technical Bid.
- 1.4 Copy of income tax return for the last three consecutive years to be submitted.
- 1.5 The tenderer shall submit copies of PAN Card, GST registration Certificate, Labour License, PF.
- 1.6 The Original tender copy marked duly completed and signed on each page should be submitted along with the offer.
- 1.7 The tender is two bid and therefore should be placed in two sealed covers super-scribing technical bid and financial bid along with the full name of the work .The full name, postal address of the tenderer shall be written on the bottom left corner of the sealed cover.

- 1.9 **Non-conformity** of any of the terms and conditions along with non-submission of any of the documents mentioned above **will disqualify** the tenderer.

- 1.12 Contractor must submit experience of executing civil works during last 3-years. Fresh Contractors having a Graduate Degree of Engineering are exempted from submitting experience. Proof of Graduate Degree in Engineering from AICTE recognised institute to be submitted.
- 1.13 The payment will be made as per measurement.
- 1.14 Intending tenderers should visit site and proof of site visit (format enclosed) need to be submitted along with tender document. Site Visit will be provided by JE/ Executive Engineer, CU.  
**Non Submission of site visit certificate will lead to rejection of techno-commercial bid.**
- 1.15 Security Deposit amounting 8% (For General) & 9% (For Reserved) of the billed value will be deducted from bills which will be refunded after Six (6) months from the date of issue of completion certificate. The defect liability period for the work shall be Six (6) months from the issue of the completion certificate.
