1. General Terms and Conditions:

- 1.1. There is an application fee (non-refundable) for an amount of Rs. 500.00 (Rupees Five hundred only) which is to be submitted for collecting the detailed bid document. The requisite fee can be deposited through ICICI Bank Challan— FEE CODE 011, available alongside the concerned Notice Inviting Quotations in the website www.cottonuniversity.ac.in
- 1.2. The detailed bid document along with samples of the required items may be collected from the Administrative Building, Cotton University after having deposited the said application fee. Those who collect and submit the detailed bid document in a manner stated otherwise will be treated as disqualified.
- 1.3. The bid package must be submitted in two separate sealed envelopes titled:
 - (i) 'Technical Bid', containing all relevant documents in support of necessary compliances and technical credentials; and
 - (ii) 'Financial Bid', containing the duly filled-in relevant columns concerning financial involvement
- 1.4. The above two sealed envelopes as mentioned in clause 1.3 should be put together in one big sealed envelope clearly super-scribed on the top of the big envelope as "APPLICATION FOR SUPPLY OF PRE-PRINTED PAPER ITEMS" and submitted to The Registrar, Cotton University, Panbazar, Guwahati-781001 on or before 18th April, 2018 until 2:00PM.
- 1.5. Earnest Money Deposit (EMD) through Demand Draft/Banker's Cheque must be deposited in a small sealed envelope in favour of Cotton University @2% of the total value and not just on the unit prices.
- 1.6. Financial Bid will be considered only after qualification of the bidder in the first phase of bid evaluation exercise, i.e. Technical Bid evaluation.
- 1.7. The prices of items should be quoted FOR destination (Cotton University).
- 1.8. Non-conformity to any of the terms and conditions along with non-submission of any of the documents/testimonials and/or requisite fees mentioned above will disqualify the applicant and their Financial Bid will not be considered by the scrutiny and evaluation committee or the authority.
- 1.9. Cotton University reserves the right to modify/cancel the minimum requirements. It also reserves the right to accept, consider or reject any or all of the applications without assigning any reason thereof. The decision of Cotton University in respect of scrutiny, evaluation and selection of parties will be intimated by the office and shall be final.
