During document verification the students must produce the following documents:

- (i) Original marksheet where the Seal of Free Admission into Cotton University in 2018 had been stamped on the backside.
- (ii) Valid Income Certificate in original from the Local Revenue Circle Officer only which states that the parental income is less than Rs. 2.00 lakhs from all sources.
- (iii) Fresh photograph of the sapling planted in 2018 (in 2017 in case of 5th Semester students).
- (iv) For HS 2nd Yr admission, student must bring the original and photocopy of the HS 1st yr marksheet. UG/PG students must bring original and photocopies of the mark sheets of previous semester examinations. Note that the scheme is NOT applicable to students with back paper.
- (v) The students under the fee waiver scheme will have to pay Students' Welfare and Activity fee, Students' Union fee, and Magazine fee.
