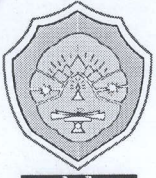

The Anti-Ragging Committee will ensure in compliance with the provisions of the UGC regulations as well as provisions of any new law for the time being enforced concerning ragging and monitor/oversee the performance of the anti-ragging squad to prevent ragging in any form in the university.

The committee on receipt of recommendation of the Anti-Ragging squad or on receipt of any information of incident of ragging may proceed to file FIR at the local police station within 24 hours of such information or recommendation.

The committee shall recommend disciplinary action to the university authority if any student is found guilty of ragging. The Anti-Ragging Committee shall be valid for a period of 2 (two) years or until further order whichever is earlier w.e.f. the date of issue of this notification.
