NOTICE INVITING TENDER

Notice inviting Tenders (NIT) are invited in Single Bid from interested contractors who fulfil the eligibility criteria provided below for "REPAIRING IN PATCHES OF CERTAIN SECTIONS IN THE INTERNAL ROADS IN THE COTTON UNIVERSITY, PANBAZAR, GUWAHATI-01".

1. General Terms and Conditions:

The applicant should meet the following minimum terms and conditions and criteria:-

- 1.1 There will be **Tender fee (non-refundable)** of an amount of **Rs. 500.00 (Rupees Five hundred only)** to be submitted in the form of Demand draft in favour of "The Registrar, Cotton University" payable at Guwahati along with the tender documents.
- 1.2 The tenderers should be registered in APWD (Buildings) not more than Class-I (C) category.
- 1.3 Average Annual turnover in last 3 (three) years should be at least Rs. 10 lakhs
- 1.4 Copy of income tax return for the last three consecutive years to be submitted.
- 1.5 The tenderer shall submit copies of PAN Card, GST registration Certificate.
- 1.6 The Original tender copy marked duly completed and signed on each page should be submitted along with the offer.
- 1.7 The tender is single bid and therefore should be placed in single sealed covers super-scribing the full name of the work. The full name, postal address of the tenderer shall be written on the bottom left corner of the sealed cover.
- 1.8 The documents to be submitted by the tenderer may be downloaded from the official website of Cotton University.
- 1.9 An amount equivalent to 10% of the total bill value will be deducted as security money which will be refunded after the defect liability period.
- 1.10 The tenderer should have previous experience of Repairing works in buildings in Govt. Deptt./ PSU/Autonomous Body/ Semi- Govt. Deptt. etc. Relevant orders shall be submitted along with the Tender document.
- 1.11 **Non-conformity** of any of the terms and conditions along with non-submission of any of the documents mentioned above **will disqualify** the tenderer.
- 1.12 Cotton University reserves the right to accept, consider or reject any or all of the applications without assigning any reason thereof. The decision of CU in respect of scrutiny and selection of contractor will be intimated by the office. All disputes in this connection shall be settled in **Kamrup Metropolitan** district jurisdiction only.
- 1.13 The tenderers are required to quote the rate for the work in the **Price Bid** in Annexure- I in words and figure. The rate shall be inclusive of all taxes and duties.

Last date of submission of tender document is 31st of August 2023 upto 2:00 P.M.

2. General Specification of the work:

- 2.1 The work shall include Dismantling of damaged portion of internal road, removal of debris, necessary excavation, compaction along with Cement concrete 1:2:4 (1 cement : 2 coarse sand : 4 graded stone aggregate 40 mm nominal size) in pavements, laid to required slope as required including consolidation finishing and tamping complete.
- 2.2 Approximate total length of the internal road is 750m and average width of the internal road is 3.25m.
