The project grant will be maximum of Rs. 1(one) Lakh for Science Stream and Rs. 50(fifty) thousand for Arts & humanity stream.

Following points are the conditions for being deemed fit to apply for the In House Research Proposals (IHRP)

- 1. Those who have no other Research Project/Projects from any other agencies.
- 2. The faculty members should be permanent employees of the University.
- 3. No creation of physical infrastructure should be proposed.
 - The expenditure involved may be minor chemicals, books, minimum travel cost (cheapest), contingencies, Hiring or Cost of analysis/data collection at any Institute/laboratories.
 - The proposals will be screened and finally awarded by a **Selection Committee**, **IHRP** approved by hon'ble Vice-Chancellor.
